#### **Approve 2021 Chemical Bid Award**

Mr. Wallette reviewed the 2021 Chemical Bid Summary with the Board which included his recommendations for award.

As Vice President of the American Mosquito Control Association, Mr. Wallette attended the Interim Board Meeting in November. He is currently involved in putting together the meeting program for 2021 which will be held virtually.

The Leadership Tangipahoa group visited the District office October 20th.

### Assistant Director's Report - Ms. Colona provided her report.

Trap runs have been concluded for this season.

We submitted a total of 2,183 mosquito samples to LSU for testing compared to 2,139 for last year. There were 33 mosquito pools that tested positive for West Nile Virus compared to 7 mosquito pools testing positive last year.

In house LAMP testing totaled 286 samples with 5 samples testing positive for West Nile Virus compared to 149 samples with no positives last year.

Ms. Colona gave a program update presentation of our District for the virtual LMCA Annual Meeting.

Ms. Colona conducted our quarterly District Safety Meeting which included handling materials safely.

Mr. Wallette reviewed the financial report through November 30th, 2020.
