# TANGIPAHOA MOSQUITO ABATEMENT DISTRICT #1 MINUTES, REGULAR MEETING, MAY 8, 2024

Our annual audit will be conducted by Laura Gray, CPA, She provided the commissioners with her audit responsibilities, information related to the audit of the financial statements of the District, her planned scope and timing of the audit and provided her contact information for open communication during the audit process.

#### **Review Financial Statement**

Ms. Colona reviewed the financial report through April 2024. Due to a massive increase this year in the cost for property, vehicle, general liability, and management liability insurances, Ms. Colona made a recommendation to transfer \$185,350.00 from reserves to these insurance categories. She is also contacting other insurance agencies for quotes in an effort to reduce the insurance costs for the remainder of the year.

# **Director's Report**

Ms. Colona provided her report. Last month, nuisance mosquito counts were high and the southern house mosquito counts are lower, but currently on the rise, which is typical for May and June. There have been no human cases and no positives for West Nile virus out of 600 tested mosquito pool samples.

Jourdan McGaughey has been hired, filling the position of entomologist.

Andrew Scherer, public outreach specialist, has been updating the look of our Facebook page, has written press releases, contacted radio stations and multiple newspapers to set up interviews, and is working with Alex Fortenberry, IT Specialist, on developing risk maps for the public.

Ms. Colona attended the parish council meeting in April where she introduced herself to the council members. Before leaving the meeting, Action News 17 reporter, Ken Benitez, interviewed Ms. Colona.

The LMCA spring workshop was held in Baton Rouge in April. Two inspectors attended this training.

#### **Review 2024 Reassessment Value**

The 2024 millage will be adopted at our next meeting.

# **Award Hangar Bid**

Mr. Tom Pistorious reviewed the bid tabulation sheet with the commissioners and answered questions. There were seven bids submitted with one bid disqualified due to the envelope being incomplete.
