## **Assistant Director's Report**

Ms. Colona provided her report. There has been an increase in mosquito activity since March, which is typical this time of the year. The worst time of the year is typically spring/early summer. As of May 5th, there have been no positives for West Nile virus out of 545 tested mosquito pool samples at LSU and 33 mosquito pool samples tested in house at the District. Last year at this point there were 261 combined tests with no positives to date.

On March 16th, Ms. Colona did a presentation to the entire 3<sup>rd</sup> grade at Hammond Westside Montessori.

Ms. Colona gave a presentation on electrical safety at the District's quarterly safety meeting. A bottle bioassay was conducted on April 13th. All but one chemical is at greater than or equal to 98% average mortality.

At the end of March, Ms. Colona attended the Anastasia Mosquito Control Workshop in St. Augustine, Florida.

Employee, Alex Fortenberry, received his 8A certification, so now all full-time employees at the District are licensed.

Ms. Colona has been attending virtual training for a new arboviral reporting system.

Ms. Colona received acceptance to the Board-Certified Entomologist program through the Entomological Society of America and will be preparing for exams over the next few months. The District completed a Cage Test on May 9th on a new product, ReMoa Tri.

Upcoming events are: Continue spraying, setting traps, submitting samples, and conducting in house testing (LAMP).

National Mosquito Control Awareness week is June 18th – 24th.

#### **Director's Report**

Mr. Wallette provided his report.

Plans for the District Hangar and bid packages are almost complete. We should be able to advertise for bids before the end of the month.
